### **PRODUCT DESCRIPTION**

**SCALDFREE**, is a damage preventer cold and physiological disorders in pre-, post-harvest and cold storage in Pome.

Powder product based on organic acids and glycine betaine.

The product is aimed at damage control by cold and scalding stress by low temperatures, and the corresponding set of symptoms in storage at Pome. Foliar applied as a translucent film, which is dried and washed is easy.

Among its attributes: reduction in symptoms of injury from scalding, water stress reduction associated with low-temperature stress, achieving better quality fruits and conservation potential of fruit quality in storage.

IMPORTANT: Requires the use of surfactants to achieve a better distribution on the blade, nonionic surfactants are recommended or organo-silicone. Recommended applications to slightly acidic pH to neutral (pH 5.5 to 7.0).





# PRECAUTIONS FOR USE

1.-When handling the product must wear gloves, masks, goggles and appropriate clothing.

2.-Avoid contact with skin and eyes if so: wash with water. If ingested or inhaled seek medical care immediately.

3.-The product should be stored in its original packaging, with your respective label, in a cool, dry and closed.

4.-Do not eat, drink or smoke when using this product.

5.-To avoid contamination remove the packaging after making a triple wash.

6.-In extreme weather conditions of rain use window allowing 4 hours without rainfall.

7.-After handling the product wash hands, face, or any exposed area.

8.-Do not store or transport near food or clothing.

9.-To get a good job, you should: a) Read the instructions for use. b) Shake vigorously in the pool of application. c) Use the appropriate water volume depending on the dose stated on the label.

10.-SCALDFREE is compatible with most pesticides. Previous tests are recommended prior compatibility.
